Testimony on the Latest Congressional Redistricting Map
To: Justice McAllister

As I look at the new map, I am dismayed that much of the northeast Bronx would be removed from NY-16, significantly decreasing the Black voter population in the district. The effect of this map would be to dilute the voting power of communities of color, further marginalizing them and making it difficult for them to elect candidates who best represent their interests, while strengthening the power of white and wealthy communities in the suburbs.

It would be deeply troubling to see the predominantly Black community of the northeast Bronx being broken up into three congressional districts (Co-Op City in NY-14, Williamsbridge and Baychester in NY-15, and Edenwald kept in NY-16), thus splitting these communities of interest.

At a time of rampant voter suppression of Black and BIPOC communities around the country, it would be deeply tragic to see NY join those ranks.

For the purpose of racial justice, as well as the value of having a district with both racial and class diversity, I strongly urge you to redraw the map to keep the northeast Bronx (Co-Op City, Edenwald, and Williamsbridge) together with lower Westchester.

I do not wish to micromanage your efforts, but I do have concerns I would like to express.

I am a resident of the City of Saratoga Springs, New York, and I must say that I am strongly opposed to being moved from the 20th to the 21st Congressional District.

Dear Judge McCallister,

I am writing to urgently request that you rule special master Dr. Jonathan Cervas' proposed congressional and state senate maps, released publicly on May 16, 2022, unconstitutional. I believe your best decision would be to reinstate the state legislature's maps for one election cycle to allow appropriate time and process for a new set of independently drawn maps to be drawn and commence in the 2024 election.

The special master's proposed maps are different than the state legislature's maps, however, they are barely an improvement. For the city of Auburn they are devastating. In a letter to you on May 5, 2022 our Mayor, Michael D. Quill respectfully requested that the City of Auburn be included in central New York oriented districts, as that best represents our government and cultural interests. The special master's map proposals for both the congressional districts and the state senate district draw the city of Auburn into districts that have minimal to do with our central New York interests and frankly will curtail many issues as we will likely find ourselves represented by individuals that have no interests in central New York. Furthermore, after analyzing the complete set of maps myself, I can only conclude that the special master's proposals are just as bad as the state legislature's.

To conclude, if everything you determined about the state legislature's maps holds constant you must remain consistent and rule the special master's proposed maps unconstitutional, reset the process and hold the state legislature accountable to upholding an independent redistricting process.
