DEFENDANTS' UNOPPOSED MOTION FOR LEAVE TO FILE A SINGLE MOTION FOR SUMMARY JUDGMENT IN CONSOLIDATED CASE WITH AN EXTENDED PAGE LIMIT OF 55 PAGES

Defendants Galveston County, Texas, the Galveston County Commissioners Court, County Judge Mark Henry, and County Clerk Dwight Sullivan ("Defendants"), respectfully move the Court for leave to file: (1) a single Motion for Summary Judgment against all Plaintiffs in this action, and (2) their single Motion for Summary Judgment with an extended page limit of no more than 55 pages. Plaintiffs do not oppose these requests.

1. Across the three Complaints consolidated in this case, Plaintiffs generally allege that the Commissioners Court precinct map adopted in 2021 violates Section 2 of the Voting Rights Act of 1965 ("VRA") and the Fourteenth and Fifteenth Amendments to the United States Constitution. See ECF 42 (Petteway Plaintiffs' Second Amended Complaint);¹ ECF No. 45 (Order Consolidating cases).

2. Because all Plaintiff groups brought VRA Section 2 claims and two of the

Plaintiff groups brought race-based constitutional claims, there is a nexus of facts and issues across the three consolidated cases in this action. Granting Defendants leave to file one Motion for Summary Judgment on all claims will allow the Court to review interconnected facts and issues in a single brief, rather than reviewing three filings with a repetitive analysis.

3. Should the Court grant Defendants leave to file a single Motion for Summary Judgment against all Plaintiffs, Defendants further request that the Court grant Defendants leave of the 30-page limit set by Gal. Div. R. Prac. 5(f). Specifically, Defendants seek leave to file a single motion of no more than 55 pages, rather than three separate 30-page motions.

4. Additionally, Defendants state that they would be unable to sufficiently and properly present and address both the VRA Section 2 and constitutional issues in one 30-page summary judgment filing. An extension of the page limit, on the other hand, would afford Defendants the opportunity to appropriately brief the Court on the common legal issues surrounding Plaintiffs' claims.

5. Defendants have conferred with each of the Plaintiffs in this consolidated action, and counsel for all three groups has stated that they do not oppose the instant Motion.

WHEREFORE, Defendants respectfully request that the Court grant leave for them to file: (1) a single Motion for Summary Judgment against all Plaintiffs, and (2) their single Motion for Summary Judgment with an extended page limit of no more than 55 pages (instead of 30 pages). Plaintiffs do not oppose this request.
