DEFFENDANTS' OBJECTIONS TO PLAINTIFFS' <u>PROPOSED TRIAL EXHIBITS</u>

Attached as "Exhibit A" are Defendants' objections to Plaintiffs' proposed exhibits.

Defendants also submit the following explanations for objections to specific exhibits.

I. Relevance: "what was relevant decades ago does not shed light on current conditions or needs."

The Supreme Court has clearly held that what was relevant decades ago does not

shed light on current conditions or needs. See Shelby Cnty. v. Holder, 570 U.S. 529, 552-

53 (2013) (noting "history did not end in 1965," more than 40 years passed between preclearance laws' enactment and their reauthorization in 2006, and focusing on "decades-old data relevant to decades-old problems, rather than current data reflecting current needs" was not appropriate). As the Court has stated in the context of the Fifteenth Amendment, it is "not designed to punish for the past; its purpose is to ensure a better future." *Id*.

The broad reach of Section 5 of the Voting Rights Act ("VRA") was upheld in the past based on situations that "have unquestionably improved." Nw. Austin Mun. Util. Dist. No. One v. Holder, 557 U.S. 193, 202 (2009) ("Things have changed in the South. Voter turnout and registration rates now approach parity. Blatantly discriminatory evasions of federal decrees are rare. And minority candidates hold office at unprecedented levels"). In Northwest Austin, decided 14 years ago, the Court held the VRA "imposes current burdens and must be justified by current needs." Id. As where the VRA's coverage formula was based on stale data over 35 years old, and failed to consider current political conditions (such as the racial gap in voter registration and voter turnout rates), claims brought under Section 2 of the VRA cannot be based on stale facts. See id. at 203. The Court also rejected the argument that the VRA's preclearance requirements had a "deterrent effect" and striking down Section 5 would encourage jurisdictions to resume discriminating if struck down, stating that such a theory would make Section 5 "immune from scrutiny; no matter how "clean" the record of covered jurisdictions, the argument could always be made that it was deterrence that accounted for the good behavior." Shelby County, 570 U.S. at 550. In Brnovich, which considered a Section 2 challenge to a voting regulation, the Court held that it is relevant to consider current conditions and how they have improved. See Brnovich

v. Democratic Nat'l Comm., 141 S. Ct. 2321, 2338-2339 (2021) (explaining "partisan

motives are not the same as racial motives").

II. Hearsay – News Articles

Defendants object to the admission of news articles to prove the truth of the matter asserted. The Fifth Circuit has held that news articles contain inadmissible hearsay. *Dallas Cnty. v. Commercial Union Assur. Co.*, 286 F.2d 388, 391–92 (5th Cir. 1961) ("Of course, a newspaper article is hearsay, and in almost all circumstances is inadmissible"). As has occurred in depositions, witnesses may lack personal knowledge of the statements therein, and the comments within them may be speculative and irrelevant to the issues before the Court. While certain exceptions to the rule against hearsay may exist for specific articles, or for use with specific witnesses, Defendants object to the automatic inclusion of such articles into the record without establishing admissibility.

VII. FRE 401/403 – Irrelevant and Confusing Issues

Defendants object to the use of documents and information that is wholly irrelevant

to this litigation, and which confuse the issues and elements of proof in this case. For

example, for the Voting Rights Act vote dilution claim, Plaintiffs must show the three

Gingles preconditions, and then the "Senate factors" may be considered:

- 1. the extent of any history of official discrimination in the state or political subdivision that touched the right of the members of the minority group to register, to vote, or otherwise to participate in the democratic process;
- 2. the extent to which voting in the elections of the state or political subdivision is racially polarized;
- 3. the extent to which the state or political subdivision has used unusually large election districts, majority vote requirements, anti-single shot provisions, or other voting practices or procedures that may enhance the opportunity for discrimination against the minority group;
- 4. whether members of the minority group have been denied access to [any candidate slating] process;
- 5. the extent to which members of the minority group in the state or political subdivision bear the effects of discrimination in such areas as education, employment and health, which hinder their ability to participate effectively in the political process;
- 6. whether political campaigns have been characterized by overt or subtle racial appeals; [and]
- 7. the extent to which members of the minority group have been elected to public office in the jurisdiction.
- 8. whether there is a significant lack of responsiveness on the part of elected officials to the particularized needs of the members of the minority group; [and]
- 9. whether the policy underlying the state or political subdivision's use of such voting qualification, prerequisite to voting, or standard, practice or procedure is tenuous.

See Thornburg v. Gingles, 478 U.S. 30 (1986); Anne Harding v. Cnty. of Dallas, 948 F.3d

302 (5th Cir. 2020). Under *Gingles* factor 1, for example, evidence concerning discrimination would be relevant if it (a) involves *official* discrimination in Galveston

County, and (b) touches on the right of the members of the minority group to register, vote,

or participate in the electoral process.
