ORDER RELATING CASES AND **REQUIRING PARTIES TO FILE** CONSOLIDATED JOINT CASE MANAGEMENT STATEMENT

Re: Dkt. No. 42

On July 27, 2020, Plaintiffs filed the instant action against Defendants. ECF No. 1. On July 29, 2020, plaintiffs in a later-filed action, California et al. v. Trump, et al., No. 20-cv-05169-EMC (N.D. Cal., filed July 28, 2020), filed a motion to relate the later-filed action to the instant action. ECF No. 12.

On August 14, 2020, Defendants filed a statement noting that they "do not oppose relating these cases, as they concern substantially the same parties, transaction[,] or event, and it appears likely that there will be an unduly burdensome duplication of labor or conflicting results if the cases are conducted before different Judges." ECF No. 42 at 2 (quotation marks, citations, and internal alterations omitted). Accordingly, the Court RELATES California et al. v. Trump, et al.,

Additionally, on August 12, 2020, the Court advanced the October 28, 2020 case management conference to August 18, 2020 at 10:30 a.m. via Zoom video conference. ECF No. 38. Per Defendants' request, the Court "permit[ted] the filing of a simplified [joint case management statement,] which only requires that the parties address (i) scheduling for dispositive motions; (ii) the appointment of a 3-judge panel under 28 U.S.C. § 2284; and (iii) the interplay between this case and the other pending cases Plaintiffs listed." ECF No. 36 at 2.

Because the Court has now related California et al. v. Trump, et al., No. 20-cv-05169-EMC (N.D. Cal., filed July 28, 2020), to the instant case, the parties in *California et al. v. Trump*, et al., No. 20-cv-05169-EMC (N.D. Cal., filed July 28, 2020), shall appear at the August 18, 2020 case management conference. The parties in both cases shall file one consolidated joint case management statement by August 17, 2020 at 2:00 p.m. The parties' consolidated joint case management statement shall address the issue of consolidation. The parties shall file the one joint case management statement on the dockets of both cases because the cases are not consolidated at this time.
