On behalf of Respondent Michael J. Stack III, in his Capacity as Lieutenant Governor of Pennsylvania and President of the Pennsylvania Senate Respondent Stack, pursuant to this Court's January 22 and 26, 2018 Orders, files the attached documents with the Court:

- 1) Respondent Stack's Statewide Submission Map (the "Stack Map"), showing the addresses of incumbent representatives and the candidates for the special election in the 18th congressional district¹;
- 2) The corresponding narrative description for each proposed district;
- 3) The population per proposed district;
- 4) The measured compactness report for the proposed districts;
- 5) Enlarged portions of the Submission Map for Southeastern, Northeastern, and Southwestern Pennsylvania; and
- 6) County, municipality, ward, and precinct splits for the proposed map.

Pursuant to the Court's February 14, 2018 correspondence, census block data and ESRI shape files for the Stack Map are being sent to this Court via electronic mail.

Before this Court, Respondent Stack has emphasized Chen Figure 1 as a map, developed by Expert Witness Dr. Jowei Chen, that respects the neutral redistricting criteria set out in the Court's January 22 Order while also tracking

Pennsylvania's historic communities of interest.² The Stack Map is based in large part on Chen Figure 1, but with certain modifications.

First, at trial, Dr. Chen noted that his simulations did not take into account the requirements of the Voting Rights Act, but that the Second Congressional District in the 2011 Plan was approximately 56.8% African American. (Pet. Ex. 1 at 33). Chen Figure 1 did not include a majority-minority district. (Pet. Ex. 3). The Stack Map includes a congressional district in Philadelphia that is approximately 58.7% African American.

Second, certain modifications were made to further protect communities of interest. For example, Chen Figure 1 places Monroe County with Northampton and parts of Lehigh County. The Stack Map includes a district that combines all of Northampton and Lehigh County with the majority of Carbon County, better reflecting the historical community of interest centered in the Allentown area. The Stack Map further includes Monroe County with Lackawanna County, creating a compact Northeastern District with common communities of interest.

Additionally, the Stack Map creates a compact Southwestern District with common communities of interest, including Southern Allegheny, Washington, Greene, and Fayette Counties.

Third, having met the integral and primary criteria of equal population, contiguity, compactness, and respect for political subdivisions, the Stack Map includes certain minor adjustments that avoids placing congressional incumbents running for re-election in 2018 in separate districts. The following chart summarizes the treatment of incumbents:

Respondent Stack has incorporated these adjustments to Chen Figure 1 while meeting the traditional criteria required by this Court. Chen Figure 1 splits 14 counties. The Stack Map similarly splits 14 counties. Chen Figure 1 has an average Reock Compactness Score of 0.442. The Stack Map has a mean Reock Compactness Score of 0.45. Both Chen Figure 1 and the Stack Map have a Polsby-Popper Compactness Score of 0.310. The Stack Map, therefore, meets the same criteria of one of the non-partisan computer generated maps offered in the litigation; preserves communities of interest; respects the integrity of political subdivisions, notably county governments; creates a majority-minority district under the Voting Rights Act and avoids the placements of two incumbents in the same district.

WHEREFORE, Respondent Stack submits this proposed districting plan for this Honorable Court's consideration.




