Proposed 17-district congressional redistricting map files

3. Pursant to the Court's Order on January 24th, 2022, paragraph 1, attached is a zip file named Amicus_Kozykowski_Map_files.zip that contains the electronic files associated with the Proposed 17-district congressional redistricting map Amicus Kozykowski submitted on January 24th, 2022, prior to receiving the Judge's Order dated January 24th, 2022.

4. Amicus Kozykowski used davesredistricting.org to create the files in the aforementioned zip file.

5. Amicus Kozykowski copied the description of each file in the aforementioned zip file from davesredistricting.org.

6. The aforementioned zip file contains the following files:

7. block-assignments.csv is a mapping of census blocks to district IDs, without export alternate census blocks.
8. block-assignments_alternate.csv is a mapping for census blocks to district IDs, with export of alternate census blocks.
9. district-abstract.json is selected district data used by analytics.
10. district-data.csv is all census, voting age and election data (except PVI), aggregated by district.
11. district-shapes is district shape geometry as Shapefile.
12. district-shapes.geojson is district shape geometry.
13. map-analytics.json is is basic and advanced analytics.
14. map-archive.json is an archive that cna be reimported.
15. map-image.png is an image of the state showing the district.
16. precinct-assignments.csv is a mapping of precincts to district IDs.
17. precinct-data.csv is all census, voting age and election data (except PVI), by precinct.
