**ORDER RE ARB MOTION FOR PARTIAL RECONSIDERATION OF ORDER
FOLLOWING *IN CAMERA* REVIEW**

The Alaska Redistricting Board has moved for partial reconsideration of the Court's *Order re Second In camera Review* issued earlier today. The Board notes it seeks further review under the *In Re Mendel*¹ process. The Court acknowledges that *In Re Mendel* directs the Court to provide an opportunity for objection following the court's *in camera* review. Since ARB has now submitted further objections, the Court will undertake a further review. Plaintiffs may file a response to the Board's Motion by 10am on Sunday, January 23, 2022. The Board need not produce the additional documents until the Court completes its further review and issues a further order on reconsideration. If any Plaintiff opposes the Motion, then ARB may file a Reply not later than 1pm on Sunday, January 23, 2022.
