RESPONDENTS' MOTION FOR AN EXTENSION

The respondents respectfully move the Court for an extension of time to file a petition for rehearing en banc. The current deadline is Tuesday, June 20, and the respondents request an extension of 30 days. The new deadline, if the Court were to grant the request, would be Thursday, July 20.

The reason for the requested extension is the trial in the underlying case. This matter is before the Court on a petition for a writ of mandamus seeking relief from discovery orders in *Turtle Mountain Band of Chippewa Indians v. Howe*, No. 3:22-0022 (D.N.D.). That case went to trial from June 12 until today, and post-trial briefs are due on June 30.\* Attorneys for the

respondents have been consumed with that trial and do not have enough time after trial to prepare a petition for rehearing by the current deadline.

Although the requested extension is longer than the Court usually grants, this case presents unusual circumstances. The legislative-privilege issues presented here are important, and the panel's 2-1 decision conflicts with decisions of other circuits on those issues. *See, e.g., Jackson Mun. Airport Auth. v. Harkins,* 67 F.4th 678, 686-87 (5th Cir. 2023) (requiring legislators to produce a privilege log); *id.* at 687 (holding that some legislative communications with third parties are non-privileged). A thorough petition for rehearing en banc will allow the entire Court to consider these important issues fully.
