**STIPULATION TO FILE AMENDED COMPLAINT  
AND JOINT MOTION TO EXTEND RESPONSIVE DEADLINES**

On January 13, 2023, Plaintiffs moved for leave to file an amended complaint. The parties have since reached an agreement regarding Plaintiffs' motion. As part of that agreement, Defendants stipulate to the entry of an order that grants Plaintiffs' motion. The parties also enter these stipulations:

- The individual (non-organizational) Plaintiffs must serve all non-privileged documents responsive to Defendants' pending discovery requests no later than thirty days from the date of this stipulated motion.
- As to the new individual (non-organizational) Plaintiffs who first appeared in the amended complaint, the parties stipulate that the written discovery previously served by Defendants on the other individual Plaintiffs named in the initial complaint applies to the new individual Plaintiffs without the need for new service.
- Defendants must file any responsive motions/pleadings within 20 days after the Court enters an order that grants Plaintiffs' motion for leave to file an amended complaint.

WHEREFORE, the parties respectfully request entry of an order an order that grants Plaintiffs' motion for leave to file an amended complaint and extends Defendants' deadline to respond to the amended complaint.
