

Dear Justice Protasiewicz,

Congratulations on your recent election to the Wisconsin Supreme Court.

Earlier this week, you released a May 31, 2023 letter from the Wisconsin Judicial Commission (“the Commission”) stating that it had “considered several complaints” alleging that you violated various Supreme Court Rules and the Code of Judicial Conduct. The letter also stated the Commission dismissed “these complaints without action.”

Per Wis. Stat. §757.93 (1)(a), Under Wisconsin Statutes, Judicial Commission proceedings are confidential unless a “judge...waives the right to confidentiality in writing to the commission.”

In the interest of transparency, we ask that you inform the Commission in writing by Monday, September 18, 2023 that you waive your right to confidentiality in the complaints which were dismissed by the Commission pursuant to the May 31, 2023 letter.

As you know, your conduct and comments have been the subject of great discussion across Wisconsin. You may not be aware that the appointment/reappointment of five members of the Judicial Commission are currently before the Senate Committee on Judiciary and Public Safety (“Committee”).

By releasing the Commission’s May 31, 2023 letter, you have concluded that the public’s interest in the Judicial Commission’s activity outweighs any personal privacy interest you wish to protect. But releasing only the conclusion and one of the “several” complaints made against you leaves the public with an incomplete record and invites speculation.

By formally waiving your right of confidentiality of these complaints, it will allow the Commission to release records and shed light on a number of subjects, including: your alleged conduct during the campaign for Supreme Court and its interaction with Supreme Court Rules, the Code of Judicial Conduct and its enforcement, and the operation and rationales of the Judicial Commission. On this last subject, the Committee has received frustratingly little insight, despite more than four hours of testimony from the Commission-nominees.

We look forward to your waiver of confidentiality, and to learning more about the Commission and its process.


