Dear Clerk Christensen:

I represent the Democratic Senator Respondents in the above-captioned action (Senators Carpenter, Larson, Spreitzer, Hesselbein and Smith). On Friday, January 12, 2024, via the electronic filing system, we filed our Brief in Support of Senators Carpenter, Larson, Spreitzer, Hesselbein, and Smith's Proposed Remedial Map ("Brief"), and the Expert Report of Kenneth R. Mayer, Ph.D. in Support of Remedial Maps Proposed by the Democratic Senator Respondents ("Mayer Report").

We have identified an inadvertent error in Dr. Mayer's report with some of the partisan metrics for the proposed Assembly and Senate plans. We therefore this morning have filed via the electronic filing system a CORRECTED Brief and CORRECTED Expert Report. The corrections in both documents are only as to those metrics, which are reflected in Tables 5, A7 and A8 of the Mayer Report and discussed in both documents.
