No. 2023AP1399-OA      Clarke v. Wisconsin Elections Commission

On February 19, 2024, counsel for Governor Evers filed a letter advising that he had signed into law Senate Bill 488, which creates new legislative districts for the Wisconsin Assembly and Senate. The new law has been designated 2023 Wisconsin Act 94. The letter contends that, despite the enactment of new legislative districts, the court should retain jurisdiction over this matter "to entertain motions and address other proceedings." Letters in response to the Governor's letter were filed by a number of other parties.

The court will not take any action in response to these letters, which are not motions.

IT IS ORDERED that the court will take no action on the letters filed on February 19 and 21, 2024.
