INTRODUCTIONS: I am Ray DiRossi, caucus staff for the Ohio Senate Majority
Caucus. Here with me is my colleague Blake Springhetti, caucus staff for the
Ohio House Majority Caucus.

We are pleased to present for your consideration, a proposed general assembly districting plan for 2022 through 2032. This is the culmination of a drastically expedited process significantly delayed by the lack of timely census data. The receipt of the census data 134 days after the federally required April 1st delivery date made this process more challenging than usual.

Having previously been through this process, I want to personally thank all of the citizens of the state who took the time to testify at the regional hearings and all who took the time to submit thoughtful plans – Blake and I know the time and commitment that it takes to produce a complete plan, and I know my counterpart in the Senate Democrat caucus, Randall Rout would also acknowledge this.

Ohio's population from the 2010 census was 11,536,504. Ohio's population under the 2020 census is 11,799,448. This represents an increase of 262,944 or 2.28%. While that percentage growth over 10 years might appear small, the growth or loss of population in our state's 88 counties is varied and not certainly evenly distributed. Of the state's 33 current Senate districts, 13 are outside of the state's allowable 5% population deviation. In the House, 46 districts are currently either over populated or under populated. All under populated or over populated districts require modification simply because they do not comply with the population requirements of the Ohio Constitution.

Population shifts are also demonstrated by the change in county populations. For example, under the 2010 Census, the population of Cuyahoga County dropped by roughly 114,000. Under the 2020 Census, Cuyahoga's population has dropped by an additional 15,305 persons. Franklin County has continued its growth trend, as have Delaware and Warren counties. Also note worthy is that Hamilton county grew by over 28,000. Generally, the Appalachian region experienced population loss over the decade. Interesting fact -- If you start in the NE corner of the state in Ashtabula County and listed each county along the eastern and southern border of the state that lost

population, you would end up counting 15 counties in a row that lost population. Not until you reached Clermont County (one county shy of Hamilton/Cincinnati) would you find a county with positive growth over the last 10 years.

Blake and I want to share some observations with you about the geography of the state. While most of Ohio's 88 counties are <u>relatively</u> square or rectangular - the physical boundaries of Ohio's cities, villages and townships are far from pristine. While some townships, mainly in rural counties, are still "square-like", the boundaries of our cities and incorporated areas can take on very odd shapes. **We have some examples to show** 

**Note**: irregular geography can affect the shape of the district, especially when making efforts to preserve the integrity of the city or township. If a proposed district has an irregularly shaped jurisdiction on its outer boundary – the district shape will appear equally irregular

Stark County – Canal Fulton Canton and Massillon

Licking county – Granville, Heath and Newark

Franklin County – Columbus and other cities and townships

**Note**: The maps we have provided also include the outlines of Ohio's township cities and villages

#### **COUNTY SPLITS**

Redistricting this year is occurring for the first time under the historic amendments to our state constitution approved by the voters in 2015. These amendments provide very prescriptive, detailed, but neutral, rules for drawing state house and senate districts. The plan presented today fully complies with the requirements imposed by the state constitution. We wanted to highlight a few of those requirements.

The constitution required us to start with the largest counties in the state and proceed to the smallest counties with a population over 1.05 HD ratios. The constitution limits how certain counties can be divided depending on their population. I want to take a few moments and discuss NE Ohio and will apologize in advance for the brief recap of history. I feel this history is important for your consideration. This area of the state has been challenging to the Apportionment Boards of decades past. The specific issue is the high concentration of counties that contain enough population to be more than 1 HD. In fact, 10 counties from Lorain to the Mahoning Valley create 2 rings of counties that have additional HD and SD creation requirements. These 10 counties surround Geauga and Ashtabula counties and pin them between Pennsylvania and Lake Erie. This collection of counties also is almost 33% of the state's entire population. This mathematical challenge confronted the

1991 apportionment board and no geographic or mathematical solution was possible to fully comply with all of the requirements of the constitution. In 2001 the problem recurred but a solution was found and implemented by splitting at least 1 township. In 2011 (the current maps), the problem arose again and like 1991 and no constitutional solution was ever found or presented. Which brings us to 2021, with some additional constitutional requirements for House and Senate districts. This makes NE Ohio difficult but not impossible. The solution being proposed is the pairing of Cuyahoga and Summit counties. Those words are easy to say but difficult to implement because the combined populations (when including the remaining population in Geauga county) requires all 15 HDs to be created roughly 4% above the target population.

In addition, the Constitution contains specific language addressing the splitting of counties. The current 2011 House map splits 39 counties while the Senate map splits 19. Of these 39 and 19 splits, many were required because various Ohio counties contained too much population to avoid a split. The same is true for counties being whole Senate districts. In fact, of the 39 current House splits, (21) were required by the constitution's population requirements. On the Senate side, of the 19 current splits (8) were required.

It is therefore important for the Commission to understand that half of the county divisions in the current maps were required by the Ohio Constitution – a similar dynamic occurs in the current decade with similar amounts of required splits.

Similar reductions can be found in the proposed Senate map. The 2011 Senate map split 19 counties. The Senate map proposed today only splits 13 counties – or 6 less than the 2011 Senate map. Together, the proposal before you reduces the county splits in the 2 plans by 10.

# **Splits of Cities, Villages, and Townships**

The reforms adopted in the Ohio Constitution also address what constitutes a split of a city, village or township. The Constitution now clarifies that cities, villages or townships are considered split only when a contiguous portion is divided into separate districts. (note: this is Article XI, Section 3 (D)(1).)

Additionally, a city is <u>not</u> considered split where portions of the city are located in different counties and are placed in different districts.

Based upon these constitutional clarifications and looking at the 2011 House map, there are fourteen (14) cities/townships in the state that were split. Six of these should be obvious to all of us: Columbus, Cleveland, Cincinnati Toledo, Dayton, and Akron. These six (6) cities were, and continue to be, too large to be contained in a single HD and therefore had to be split according to the constitution. (note: this is Article XI, Section 4 (B)(1).)

In addition to these six (6) cities, a total of eight (8) other cities/townships were divided under the 2011 house map. These included Cuyahoga Falls in Summit, Massillon and Plain TWP in Stark, North Ridgeville in Lorain, Austintown TWP in Mahoning, Middletown in Butler, Mentor in

Lake and Brunswick in Medina. We are happy to report <u>none of these eight</u> governmental <u>units</u> are divided in the proposed house plan. In fact, aside from the 6 largest cities, the proposed plan only splits 1 city and 1 township. Let me tell you why.

As I mentioned previously, to implement the NE Ohio solution the remainder of Cuyahoga and Summit counties must be paired with the remainder of Geauga county in one HD. Since all 3 counties meet at one non-contiguous (or point contiguous) point, the City of Solon was split in HD 23 to accomplish this constitutional footprint.

The only other split jurisdiction in the entire proposal (again noting the Big 6 cities previously mentioned) is Jackson Township in Stark county and is done to ensure the 3 HDs are contiguous and meet the population requirements of the Constitution. As we showed visually, the geography in Stark county is very challenging. (Note: the Senate Democrat map split a different township in Stark county)

# **Article XI – Apportionment**

### § 01 Ohio Redistricting Commission

- (A) The Ohio redistricting commission shall be responsible for the redistricting of this state for the general assembly. The commission shall consist of the following seven members:
- (1) The governor;
- (2) The auditor of state;
- (3) The secretary of state;
- (4) One person appointed by the speaker of the house of representatives;
- (5) One person appointed by the legislative leader of the largest political party in the house of representatives of which the speaker of the house of representatives is not a member;
- (6) One person appointed by the president of the senate; and
- (7) One person appointed by the legislative leader of the largest political party in the senate of which the president of the senate is not a member.

No appointed member of the commission shall be a current member of congress. The legislative leaders in the senate and the house of representatives of each of the two largest political parties represented in the general assembly, acting jointly by political party, shall appoint a member of the commission to serve as a co-chairperson of the commission. Article XI: Section 1 (A) says no current member of congress can serve on the Commission and the co-chairs are to be selected by the 4 legislative leaders (Democrat and Republican)

- (B)(1) Unless otherwise specified in this article or in Article XIX of this constitution, a simple majority of the commission members shall be required for any action by the commission. Article XI: Section 1(B)(1) says a simple majority of 4 members of the Commission can take any action not otherwise specified in Article Xi OR Article XIX
- (2)(a) Except as otherwise provided in division (B)(2)(b) of this section, a majority vote of the members of the commission, including at least one member of the commission who is a member of each of the two largest political parties represented in the general assembly, shall be required to do any of the following:
- (i) Adopt rules of the commission;
- (ii) Hire staff for the commission;
- (iii) Expend funds. Article XI: Section 1(B)(2)(a)(i through iii) says a <u>bipartisan</u> majority of 4 members (with 1 minority member) of the Commission is required to adopt rules, hire staff, expend funds
- (b) If the commission is unable to agree, by the vote required under division (B)(2)(a) of this section, on the manner in which funds should be expended, each co-chairperson of the commission shall have the authority to expend one-half of the funds that have been appropriated to the commission. Article XI: Section 1(B)(2)(b) says if a bipartisan majority of 4 members of the Commission can't agree on allocation of \$ then the \$ is split 50% 50%

- (3) The affirmative vote of four members of the commission, including at least two members of the commission who represent each of the two largest political parties represented in the general assembly shall be required to adopt any general assembly district plan. For the purposes of this division and of Section 1 of Article XIX of this constitution, a member of the commission shall be considered to represent a political party if the member was appointed to the commission by a member of that political party or if, in the case of the governor, the auditor of state, or the secretary of state, the member is a member of that political party. Article XI: Section 1(B)(2)(b) says an enhanced bipartisan majority of 4 members (with 2 minority members) is required to adopt a 10-year plan
- (C) At the first meeting of the commission, which the governor shall convene only in a year ending in the numeral one, except as provided in Sections 8 and 9 of this article and in Sections 1 and 3 of Article XIX of this constitution, the commission shall set a schedule for the adoption of procedural rules for the operation of the commission. Article XI: Section 1(C) says GOV convenes 1<sup>st</sup> meeting and they must set a schedule for the adoption of Rules.

The commission shall release to the public a proposed general assembly district plan for the boundaries for each of the ninety-nine house of representatives districts and the thirty-three senate districts. The commission shall draft the proposed plan in the manner prescribed in this article. Before adopting, but after introducing, a proposed plan, the commission shall conduct a minimum of three public hearings across the state to present the proposed plan and shall seek public input regarding the proposed plan. All meetings of the commission shall be open to the public. Meetings shall be broadcast by electronic means of transmission using a medium readily accessible by the general public. Article XI: Section 1(C) says the Commission must submit a 99-house and 33-senate plan and have at least 3 public hearings across the state

The commission shall adopt a final general assembly district plan not later than the first day of September of a year ending in the numeral one. After the commission adopts a final plan, the commission shall promptly file the plan with the secretary of state. Upon filing with the secretary of state, the plan shall become effective. Article XI: Section 1(C) says the Commission shall adopt a plan by September 1<sup>st</sup> and then file with SOS after which the plan becomes immediately effective

Four weeks after the adoption of a general assembly district plan or a congressional district plan, whichever is later, the commission shall be automatically dissolved.

(D) The general assembly shall be responsible for making the appropriations it determines necessary in order for the commission to perform its duties under this article and Article XIX of this constitution. Article XI: Section 1(D) says the General Assembly is granted sole authority for appropriating money for the Commission.

## § 02 Representation

Each house of representatives district shall be entitled to a single representative in each general assembly. Each senate district shall be entitled to a single senator in each general assembly. Article XI: Section 2 says each HD = 1 Rep. & each SD = 1 Senator

## § 03 Requirements for drawing House of Representatives districts

(A) The whole population of the state, as determined by the federal decennial census or, if such is unavailable, such other basis as the general assembly may direct, shall be divided by the number "ninety-nine" and by the number "thirty-three" and the quotients shall be the ratio of representation in the house of representatives and in the senate, respectively, for ten years next succeeding such redistricting. Article XI: Section 3 says how to compute whole ratios of representation — State population of 11,799,448

/ 99 = 119,186 whole HD ratio / 33 = 357,559 whole SD ratio

- (B) A general assembly district plan shall comply with all of the requirements of division (B) of this section. Article XI: Section 3(B) says a GA plan must comply with 3 items below
- (1) The population of each house of representatives district shall be substantially equal to the ratio of representation in the house of representatives, and the population of each senate district shall be substantially equal to the ratio of representation in the senate, as provided in division (A) of this section. In no event shall any district contain a population of less than ninety-five per cent nor more than one hundred five per cent of the applicable ratio of representation. Article XI: Section 3(B)(1) lays out acceptable population deviations from the whole ratios described in Article XI: Section 3(B)

  HD ratio of 119,186 +/- 5% = +/- 5,959 = between 113,227 and 125,145

  SD ratio of 357,559 +/- 5% = +/- 17,877 = between 339,682 and 375,436
- (2) Any general assembly district plan adopted by the commission shall comply with all applicable provisions of the constitutions of Ohio and the United States and of federal law. Article XI: Section 3(B)(2) says the plan has to comply with US and Fed Constitution and fed law
- (3) Every general assembly district shall be composed of contiguous territory, and the boundary of each district shall be a single nonintersecting continuous line. Article XI: Section 3(B)(3) says all districts must be contiguous, cannot be point contiguous and can completely encircle

- (C) House of representatives districts shall be created and numbered in the following order of priority, to the extent that such order is consistent with the foregoing standards:

  Article XI: Section 3(C) says how HDs should be created and numbered
- (1) Proceeding in succession from the largest to the smallest, each county containing population greater than one hundred five per cent of the ratio of representation in the house of representatives shall be divided into as many house of representatives districts as it has whole ratios of representation. Any fraction of the population in excess of a whole ratio shall be a part of only one adjoining house of representatives district. Article XI: Section 3(C)(1) says starting with the largest county with pop > 105% of the HD ratio of (119,186) shall be divided into as many whole HDs as it has whole HD ratios. VERY WHEN 2020 COUNTY POP DAT AVAILABLE. Estimated to be these 23 counties using 2019 data: Franklin, Cuyahoga, Hamilton, Summit, Montgomery, Lucas, Butler, Stark, Lorain, Warren, Lake, Mahoning, Delaware, Clermont, Trumbull, Medina, Licking, Greene, Portage, Fairfield, Clark, Wood & Richland. Any excess goes into 1 adjoining HD
- (2) Each county containing population of not less than ninety-five per cent of the ratio of representation in the house of representatives nor more than one hundred five per cent of the ratio shall be designated a representative district. Article XI: Section 3(C)(2) says any counties with a pop between +/- 5% (between 113,227 and 125,145) shall be created as a single county district. VERY WHEN 2020 COUNTY POP DAT AVAILABLE. Estimated to be 1 county using 219 data: Wayne
- (3) The remaining territory of the state shall be divided into representative districts by combining the areas of counties, municipal corporations, and townships. Where feasible, no county shall be split more than once. Article XI: Section 3(C)(3) says to make districts from the remainder but trying to avoid splitting any remaining county more than once
- (D)(1)(a) Except as otherwise provided in divisions (D)(1)(b) and (c) of this section, a county, municipal corporation, or township is considered to be split if any contiguous portion of its territory is not contained entirely within one district. Article XI: Section 3(D)(1)(a) says any political subdivision is considered to be split if its contiguous portion is not contained in 1 district subject to Article XI: Section 3(D)(1)(b and c)
- (b) If a municipal corporation or township has territory in more than one county, the contiguous portion of that municipal corporation or township that lies in each county shall be considered to be a separate municipal corporation or township for the purposes of this section. Article XI: Section 3(D)(1)(b) says any political subdivisions that cross a county boundary are considered separate subdivisions and not split if not contained in 1 district

- (c) If a municipal corporation or township that is located in a county that contains a municipal corporation or township that has a population of more than one ratio of representation is split for the purpose of complying with division (E)(1)(a) or (b) of this section, each portion of that municipal corporation or township shall be considered to be a separate municipal corporation or township for the purposes of this section. Article XI: Section 3(D)(1)(c) says in a county where a subdivision's pop. is > whole HD ratio i.e. 119,186 and that subdivision is split to comply with Article XI: Section 3(E)(1) (a or b) that the split doesn't count. VERY WHEN 2020 SUBDIVISION POP DAT AVAILABLE what counties have a Subdivision of this size Columbus, Cleveland, Dayton, Akron Toledo etc?
- (2) Representative districts shall be drawn so as to split the smallest possible number of municipal corporations and townships whose contiguous portions contain a population of more than fifty per cent, but less than one hundred per cent, of one ratio of representation. Article XI: Section 3(D)(2) says the map must split the fewest possible # of subdivisions between 50% of 1 whole HD ratio and 1 whole ratio. VERY WHEN 2020 SUBDIVISION POP DAT AVAILABLE what subdivisions this applies to

Protected subdivisions 59,593 and 119,185

- (3) Where the requirements of divisions (B), (C), and (D) of this section cannot feasibly be attained by forming a representative district from whole municipal corporations and townships, not more than one municipal corporation or township may be split per representative district. Article XI: Section 3(D)(3) says where sections (B, C and D) can't feasibly be followed using whole units only 1 split per district is allowed
- (E)(1) If it is not possible for the commission to comply with all of the requirements of divisions (B), (C), and (D) of this section in drawing a particular representative district, the commission shall take the first action listed below that makes it possible for the commission to draw that district:
- (a) Notwithstanding division (D)(3) of this section, the commission shall create the district by splitting two municipal corporations or townships whose contiguous portions do not contain a population of more than fifty per cent, but less than one hundred per cent, of one ratio of representation.
- (b) Notwithstanding division (D)(2) of this section, the commission shall create the district by splitting a municipal corporation or township whose contiguous portions contain a population of more than fifty per cent, but less than one hundred per cent, of one ratio of representation.

- (c) Notwithstanding division (C)(2) of this section, the commission shall create the district by splitting, once, a single county that contains a population of not less than ninety-five per cent of the ratio of representation, but not more than one hundred five per cent of the ratio of representation.
- (d) Notwithstanding division (C)(1) of this section, the commission shall create the district by including in two districts portions of the territory that remains after a county that contains a population of more than one hundred five per cent of the ratio of representation has been divided into as many house of representatives districts as it has whole ratios of representation.
- (2) If the commission takes an action under division (E)(1) of this section, the commission shall include in the general assembly district plan a statement explaining which action the commission took under that division and the reason the commission took that action.
- (3) If the commission complies with divisions (E)(1) and (2) of this section in drawing a district, the commission shall not be considered to have violated division (C)(1), (C)(2), (D)(2), or (D)(3) of this section, as applicable, in drawing that district, for the purpose of an analysis under division (D) of Section 9 of this article.

## § 04\* [Effective 1/1/2021] Requirements for drawing Senate districts

- (A) Senate districts shall be composed of three contiguous house of representatives districts.
- (B)(1) A county having at least one whole senate ratio of representation shall have as many senate districts wholly within the boundaries of the county as it has whole senate ratios of representation. Any fraction of the population in excess of a whole ratio shall be a part of only one adjoining senate district.
- (2) Counties having less than one senate ratio of representation, but at least one house of representatives ratio of representation, shall be part of only one senate district.
- (3) If it is not possible for the commission to draw representative districts that comply with all of the requirements of this article and that make it possible for the commission to comply with all of the requirements of divisions (B)(1) and (2) of this section, the commission shall draw senate districts so as to commit the fewest possible violations of those divisions. If the commission complies with this division in drawing senate districts, the commission shall not be considered to have violated division (B)(1) or (2) of this section, as

applicable, in drawing those districts, for the purpose of an analysis under division (D) of Section 9 of this article.

- (C) The number of whole ratios of representation for a county shall be determined by dividing the population of the county by the ratio of representation in the senate determined under division (A) of Section 3 of this article.
- (D) Senate districts shall be numbered from one through thirty-three and as provided in Section 5 of this article.

## § 05\* [Effective 1/1/2021] Changes in boundaries of Senate districts

At any time the boundaries of senate districts are changed in any general assembly district plan made pursuant to any provision of this article, a senator whose term will not expire within two years of the time the plan becomes effective shall represent, for the remainder of the term for which the senator was elected, the senate district that contains the largest portion of the population of the district from which the senator was elected, and the district shall be given the number of the district from which the senator was elected. If more than one senator whose term will not so expire would represent the same district by following the provisions of this section, the plan shall designate which senator shall represent the district and shall designate which district the other senator or senators shall represent for the balance of their term or terms.

# § 06\* [Effective 1/1/2021] Additional district standards

The Ohio redistricting commission shall attempt to draw a general assembly district plan that meets all of the following standards:

- (A) No general assembly district plan shall be drawn primarily to favor or disfavor a political party.
- (B) The statewide proportion of districts whose voters, based on statewide state and federal partisan general election results during the last ten years, favor each political party shall correspond closely to the statewide preferences of the voters of Ohio.
- (C) General assembly districts shall be compact.

Nothing in this section permits the commission to violate the district standards described in Section 2, 3, 4, 5, or 7 of this article.

#### § 07\* [Effective 1/1/2021] Political subdivision boundaries to be used

Notwithstanding the fact that boundaries of counties, municipal corporations, and townships within a district may be changed, district boundaries shall be created by using the boundaries of counties, municipal corporations, and townships as they exist at the time of the federal decennial census on which the redistricting is based, or, if unavailable, on such other basis as the general assembly has directed.

## § 08\* [Effective 1/1/2021] Impasse procedure

- (A)(1) If the Ohio redistricting commission fails to adopt a final general assembly district plan not later than the first day of September of a year ending in the numeral one, in accordance with Section 1 of this article, the commission shall introduce a proposed general assembly district plan by a simple majority vote of the commission.
- (2) After introducing a proposed general assembly district plan under division (A)(1) of this section, the commission shall hold a public hearing concerning the proposed plan, at which the public may offer testimony and at which the commission may adopt amendments to the proposed plan. Members of the commission should attend the hearing; however, only a quorum of the members of the commission is required to conduct the hearing.
- (3) After the hearing described in division (A)(2) of this section is held, and not later than the fifteenth day of September of a year ending in the numeral one, the commission shall adopt a final general assembly district plan, either by the vote required to adopt a plan under division (B)(3) of Section 1 of this article or by a simple majority vote of the commission.
- (B) If the commission adopts a final general assembly district plan in accordance with division (A)(3) of this section by the vote required to adopt a plan under division (B)(3) of Section 1 of this article, the plan shall take effect upon filing with the secretary of state and shall remain effective until the next year ending in the numeral one, except as provided in Section 9 of this article.
- (C)(1)(a) Except as otherwise provided in division (C)(1)(b) of this section, if the commission adopts a final general assembly district plan in accordance with division (A)(3) of this section by a simple majority vote of the commission, and not by the vote required to adopt a plan under division (B)(3) of Section 1 of this article, the plan shall take effect upon filing with the secretary of state and shall remain effective until two general elections for the house of representatives have occurred under the plan.
- (b) If the commission adopts a final general assembly district plan in accordance with division (A)(3) of this section by a simple majority vote of the commission, and not by the vote required to adopt a plan under division (B) of Section 1 of this article, and that plan is adopted to replace a plan that ceased to be effective under division (C)(1)(a) of this section before a year ending in the numeral one, the plan adopted under this division shall take effect upon filing with the secretary of state and shall remain effective until a year ending in the numeral one, except as provided in Section 9 of this article.
- (2) A final general assembly district plan adopted under division (C)(1)(a) or (b) of this section shall include a statement explaining what the commission determined to be the statewide preferences of the voters of Ohio and the manner in which the statewide proportion of districts in the plan whose voters, based on statewide state and federal partisan general election results during the last ten years, favor each political party corresponds closely to those preferences, as described in division (B) of Section 6 of this article. At the time the plan is adopted, a member of the commission who does not vote in

favor of the plan may submit a declaration of the member's opinion concerning the statement included with the plan.

(D) After a general assembly district plan adopted under division (C)(1)(a) of this section ceases to be effective, and not earlier than the first day of July of the year following the year in which the plan ceased to be effective, the commission shall be reconstituted as provided in Section 1 of this article, convene, and adopt a new general assembly district plan in accordance with this article, to be used until the next time for redistricting under this article. The commission shall draw the new general assembly district plan using the same population and county, municipal corporation, and township boundary data as were used to draw the previous plan adopted under division (C) of this section.

# § 09\* [Effective 1/1/2021] Jurisdiction of Supreme Court; effect of determination of unconstitutionality

- (A) The supreme court of Ohio shall have exclusive, original jurisdiction in all cases arising under this article.
- (B) In the event that any section of this constitution relating to redistricting, any general assembly district plan made by the Ohio redistricting commission, or any district is determined to be invalid by an unappealed final order of a court of competent jurisdiction then, notwithstanding any other provisions of this constitution, the commission shall be reconstituted as provided in Section 1 of this article, convene, and ascertain and determine a general assembly district plan in conformity with such provisions of this constitution as are then valid, including establishing terms of office and election of members of the general assembly from districts designated in the plan, to be used until the next time for redistricting under this article in conformity with such provisions of this constitution as are then valid.
- (C) Notwithstanding any provision of this constitution or any law regarding the residence of senators and representatives, a general assembly district plan made pursuant to this section shall allow thirty days for persons to change residence in order to be eligible for election.
- (D)(1) No court shall order, in any circumstance, the implementation or enforcement of any general assembly district plan that has not been approved by the commission in the manner prescribed by this article.
- (2) No court shall order the commission to adopt a particular general assembly district plan or to draw a particular district.
- (3) If the supreme court of Ohio determines that a general assembly district plan adopted by the commission does not comply with the requirements of Section 2, 3, 4, 5, or 7 of this article, the available remedies shall be as follows:
- (a) If the court finds that the plan contains one or more isolated violations of those requirements, the court shall order the commission to amend the plan to correct the violation.
- (b) If the court finds that it is necessary to amend not fewer than six house of representatives districts to correct violations of those requirements, to amend not fewer than two senate districts to correct violations of those requirements, or both, the court

shall declare the plan invalid and shall order the commission to adopt a new general assembly district plan in accordance with this article.

- (c) If, in considering a plan adopted under division (C) of Section 8 of this article, the court determines that both of the following are true, the court shall order the commission to adopt a new general assembly district plan in accordance with this article:
- (i) The plan significantly violates those requirements in a manner that materially affects the ability of the plan to contain districts whose voters favor political parties in an overall proportion that corresponds closely to the statewide political party preferences of the voters of Ohio, as described in division (B) of Section 6 of this article.
- (ii) The statewide proportion of districts in the plan whose voters, based on statewide state and federal partisan general election results during the last ten years, favor each political party does not correspond closely to the statewide preferences of the voters of Ohio.

# § 10\* [Effective 1/1/2021] Severability

The various provisions of this article are intended to be severable, and the invalidity of one or more of such provisions shall not affect the validity of the remaining provisions.
