Affidavit of J. Collin Marozzi

I, J. Collin Marozzi, having been duly sworn and cautioned according to law, hereby state that I am over the age of eighteen years and am competent to testify as to the facts set forth below based on my personal knowledge and having personally examined all records referenced in this affidavit, and further state as follows:

1. In each of the above-captioned cases (Nos. 2021-1193, 2021-1198, and 2021-1210), the Ohio Supreme Court has entered an order providing that parties shall file any evidence they intend to present no later than Friday, October 22, 2021.
2. I am a Policy Strategist at the ACLU of Ohio Foundation, Inc.
