### **Affidavit of Alexander Thomson**

I, Alexander Thomson, having been duly sworn and cautioned according to law, hereby state that I am over the age of eighteen years and am competent to testify as to the facts set forth below based on my personal knowledge and having personally examined all records referenced in this affidavit, and further state as follows:

- 1. The Ohio Supreme Court has entered an order in each of the above-captioned cases,

  League of Women Voters of Ohio v. Ohio Redistricting Commission, No. 2021-1449, and

  Adams v. DeWine, No. 2021-1428, providing that parties shall file any evidence they

  intend to present no later than Friday, December 10, 2021.
- 2. I am one of the counsel for Relators in the above-captioned case, Case Number 2021-1449.
- 3. Alongside this affidavit, Relators submit several Appendices of Exhibits. The Index included at the beginning of each Appendix gives a description of each document and states where it appears in that Appendix. Each of the Indexes is also copied below.
- 4. First, the Ohio Channel makes publicly available video links of Ohio House and Senate Committee hearings and Ohio House and Senate floor debates. However, neither the Ohio Channel nor any other Ohio Legislature webpage makes publicly available official transcripts of committee hearings or floor debates. Given this, I had the hearings transcribed myself, using the following process. Following each hearing or floor debate, I copied the publicly available video link from the Ohio Channel webpage and pasted the video link into Rev.com's webpage. Rev.com is a publicly available paid service to convert audio and video to text. Rev.com uses human professionals to transcribe audio and video. After the transcription of each hearing or floor debate was complete, I

- downloaded a PDF file of the transcript. Exhibits Appendix A includes true and correct copies of the Rev.com transcripts from all hearings and floor debates that considered congressional redistricting proposals.
- Second, Exhibits Appendix B includes true and correct copies of certain other 5. government materials, including: the official transcript posted on the Ohio Redistricting Commission's website for the Commission's October 28, 2021 hearing; letters dated October 5, 2021, and October 18, 2021, from Senator Vernon Sykes to Speaker Robert Cupp; agendas for hearings held by the House Government Oversight Committee, the Senate Local Government and Elections Committee, the Joint Commission on Congressional Redistricting, and the Ohio Redistricting Commission; proposed redistricting maps, including HB 479, HB 483, SB 237, and SB 258; written testimony submitted by state legislators or their staff in support of the congressional redistricting maps, including HB 479, HB 483, SB 237, and SB 258; the September 2021 Ohio Citizens Redistricting Committee report; and the vote tally for SB 258. The agendas, proposed redistricting maps, written testimony, and SB 258 vote tally are publicly available copies posted on the committee websites or the state Legislature's website. The September 2021 Ohio Citizens Redistricting Committee report is publicly available on the Senate Local Government and Elections Committee website.
- 6. Further, the Ohio Supreme Court heard oral arguments on December 8, 2021 for the League of Women Voters of Ohio v. Ohio Redistricting Commission, No. 2021-1193; Bria Bennett v. Ohio Redistricting Commission, No. 2021-1198; and Ohio Organizing Collaborative v. Ohio Redistricting Commission, No. 2021-1210. A link to the video recording of the oral argument was made available on the public docket, which linked to

transcribed using the following process. Relator's counsel provided the direct link to the video of the oral argument hosted on the Ohio Channel website to Planet Depos, the deposition service Relators have used in this case, and ordered from them a transcription of the oral arguments. Planet Depos submitted to Relators a copy of the transcript of oral argument on December 9, 2021. Exhibits Appendix B thus includes this true and correct transcript of the December 8, 2021 oral argument before the Ohio Supreme Court.


