
ORDER FOLLOWING FURTHER IN CAMERA REVIEW

This Court has previously issued several orders addressing in camera review of privileged documents. On January 22, 2022, the Court ordered the Alaska Redistricting Board to submit further documents it identified as privileged for *in camera* review. The Board submitted the documents identified on the attached spreadsheet on January 23, 2022, and the Court conducted its review. During the course of the trial days which followed, the Court did not explicitly state its decision on this further review. Accordingly, this Order is issued in order to clarify the record.

The Board asserted either the attorney-client privilege or the attorney work-product doctrine protected the documents from disclosure. Having reviewed each of documents, the Court agrees that they are protected by the attorney-client privilege or the work product doctrine. No further production is warranted.


